The pledge of allegiance was led by deaf and hard of hearing students.

Moved (Ryan) and seconded (Beytien) to approve the agenda as submitted. Motion carried 7-0.

Moved (Prochaska) and seconded (Barton) to approve the minutes of the regular meeting on August 10, 2015, as submitted. Motion carried 7-0.

Moved (Prochaska) and seconded (Beytien) to approve those items listed in the consent agenda. Ms. Ryan was auditor for the month. Motion carried 7-0.

Boyd Card, Industrial Technology/CTE Coordinator, and Katie Gilbert, NICC, described concurrent enrollment and the partnership between DCSD and NICC. Moved (Prochaska) and seconded (Ryan) to approve the concurrent enrollment contracts with NICC for technology education, health occupations, business education, family consumer science, and construction. Motion carried 7-0.

Moved (Siegert) and seconded (Barton) to approve Change Order #2 to R & W Restoration, LLC on the Senior Stone Repointing (2015-16) Project in the decreased amount of \$22,100.00. Motion carried 7-0.

Moved (Siegert) and seconded (Barton) to approve Change Order #1 to Conlon Construction Company on the Bryant Historic Window Replacement Project in the increased amount of \$19,793.29. Motion carried 7-0.

Moved (Prochaska) and seconded (Beytien) to receive and file the abstract of votes for the school board election of September 8, 2015. Motion carried 7-0.

Moved (Prochaska) and seconded (Ryan) to approve the Attendance Awareness Proclamation. Motion carried 7-0. President Donohue read the proclamation and presented it to Shirley Horstman, Student Services Director.

Moved (Ryan) and seconded (Barton) to approve the Deaf Awareness Month Proclamation. Motion carried 7-0. President Donohue read the proclamation and presented it to Megan Johannsen, Carver deaf and hard of hearing teacher.

Mr. Krueger shared some advice on being a board member - How does this decision help <u>all</u> kids? Is this decision fiscally responsible? If in doubt, always refer back to #1.

Moved (Beytien) and seconded (Ryan) to appoint Joni Lucas, Board Secretary, as the temporary chairperson. Motion carried 7-0.

The 2014-2015 Board of Directors was adjourned. [Recess – 6:11 to 6:19 p.m.]

Ms. Lucas called the organizational meeting to order at 6:19 p.m. with the following members present at roll call: Barton, Beytien, Donohue, Prochaska, Ryan, Siegert, Wittman.

Certificates of Election were presented to newly elected member Lisa Wittman and re-elected members Tom Barton, Mike Donohue, Tami Ryan. Ms. Lucas administered the oath of office.

Moved (Ryan) and seconded (Beytien) to establish the regular meeting of the Board of Education for the second Monday of each month at 5:30 p.m. at the Forum, and strategic plan meetings the fourth Monday in October, February and June at 5:30 p.m. at the Forum. Motion carried 7-0.

Moved (Ryan) and seconded (Barton) to name Fuerste, Carew, Juergens, and Sudmeier, P.C. as the official legal counsel of record. Motion carried 7-0.

Moved (Ryan) and seconded (Siegert) to authorize the Board Secretary to cast ballots for Keystone AEA – Walter Pregler, District 8 and George Wm. Holland, District 9. Motion carried 7-0.
